LIABILITY WAIVER

FOR YOUTH VOLUNTEERS ONLY (Under 18 years of age)

Youth volunteers must be 16 years of age or older to volunteer at the shelter without a parent or guardian present, but with their written permission. Younger children can volunteer if accompanied by a parent or guardian.
